Conclusion

- **Of the 393 responses 242 (61%) are in favor of the trial on either a full time or part time basis.**
- **Of the 393 responses 148 (38%) are not in favor of the trial**
- **Of the 242 responses in favor of the trial, 161 (66%) included comments**
- **Of the 161 comments, 139 (86%) were in favor of a trial IF adaptations or other considerations were made to the design of the trial.**

These included;

- **Make the Ashley Road Car Park free for residents or free for 30-60 mins for visitors/shoppers**
- **Provisions are made for the Disabled Bays**
- **Make the whole of the High Street Pedestrianised**
- **Make the High Street One Way**
- **Ban HGVs from the High Street**
- **The area chosen for the pedestrianisation is the wrong location in the High Street. The footway is narrower from Costo – Boots. People are often queueing on the footway for the bakers, and pedestrians have to walk in the road to get pass**
- **Provisions should be made for the Fish Monger every Tuesday**
- **Provisions should be made for delivery vehicles supplying shops in the vicinity**
- **Provide additional cycle storage within the village**
- **Additional signage for the Ashley Road Car Park**
